Product Overview

This document provides an overview of the ASX Weekly Summary service.

Reference data is critical to smooth transaction management in the market. The Weekly Summary is ASX's flagship product reference and activity report, providing follow-up alerts when company announcements become actions.

The Weekly Summary provides a wealth of information to the market (typically targeted towards Information Vendors, Brokers, Institutional Back Offices and Portfolio Administrators). The Weekly Summary is a desk-top reference for all current activities in the corporate event sphere. It provides a quick reference point to check dividend details, corporate action changes or amendments and the progress of corporate takeovers or reconstructions. This data is sourced directly from ASX and is also used for running trading and settlement in the market, thereby representing the 'golden copy' version of reference data.

This service complements the ASX Daily Diary. Whilst the Weekly Summary notifies you of upcoming events such as company name changes, capital reconstruction, financial reports and issuances of new securities, the Daily Diary alerts you the day before those changes become effective.

ASX's stringent validation processes ensure the data is accurate and current, giving you a reliable tool for verifying your systems and information. Fundamental security information including company and issuer names and codes, home branches, ISIN's, GICS codes and so on, are all captured daily by ASX's Securities Administration Team, processed by ASX's internal systems and then disseminated to the market in the form of our various Reference Data products, including the ASX Weekly Summary.

Product Availability, Delivery and Format

The ASX Weekly Summary is provided by 10:00am (AEST) on Friday of each week.

The Weekly Summary is provided in PDF format (see Weekly Summary sample on page 5).

Access to the Weekly Summary is via our ASX Online Market Information B2B web portal. A unique user login is issued to persons wishing to subscribe to this product.



Specific examples of the information provided in the Weekly Summary follows:

- End of month Average Price/Earnings Ratio and Dividend Yield Series for the previous twelve months, for 20 S&P/ASX index groups and the old ASX Industrials and Resources averages.
- Headline information on what is the latest Annual, Preliminary, Interim and Quarterly company financial data announced in the previous week.
- Details of Current Calls, Convertible Note Payments, Current Dividends that had a paid date in the previous week or that are yet to be paid, and all New Issues for which the application date has not expired or where it expired in the previous week.
- Board and Management changes announced in the previous week.
- Detailed summaries of Current Offers, Name Changes and Reconstructions, Reinstatements to Official Quotation, Share Registry changes, and companies removed from the official list in the past week.
- Details of changes in substantial share holdings for companies under takeover announced in the previous week.
- Details of changes in substantial share holdings for companies <u>not</u> under takeover announced in the previous week.
- Details of listed Loan Securities that will be making an interest payment within the following six weeks.
