#### Context of this Document

The ASX Settlement Procedure Guidelines must be read in the context of the ASX Settlement Operating Rules.

Any terms explicitly defined in the ASX Settlement Operating Rules and used in the ASX Settlement Procedure Guidelines should be interpreted according to the definition given in ASX Settlement Operating Rules. This includes terms such as participant, registry, holder, issuer, subregister, and financial product. Because of the large number of these terms, they have not been capitalised for emphasis in this document.

In the interests of readability and comprehension, where a procedure applies only in the context of securities in a listed company, the specific term security has been used instead of the more generic term financial product.

## **SECTION 21. ISSUER SPONSORED ENQUIRY**

## 21.1 ISSUER SPONSORED ENQUIRY OVERVIEW

The issuer sponsored enquiry facility allows participants to determine the specific attributes of an issuer sponsored holder by sending an enquiry to the issuer, or its agent registry.

The issuer sponsored enquiry facility is an **optional** facility available to participants and issuers/registries.

Market participants have automatic access to this facility, provided they use systems supplied by a fully accredited service provider. Non-market participants may use this facility only if they lodged a settlement bond with the ASX (refer to Section 3.12.2).

CHESS provides basic validation of issuer sponsored enquiry message contents. The matching of details and retrieval of data is performed by the Issuer/Registry.

Participants can also to obtain an SRN, on behalf of a securityholder, from the Registry by completing a "Request for Securityholder Reference Number (SRN)" form, available from the relevant registry. For more information refer to Section 5.

It is the responsibility of each participant to ensure that their procedures and usage of the CHESS issuer sponsored enquiry facility is in accordance with the obligations of the ASX Settlement Operating Rules.

## 21.2 SECURITYHOLDER REFERENCE NUMBER ENQUIRY

The purpose of the Securityholder Reference Number Enquiry is to enable:

- A Participant to request a Registry to provide Securityholder Reference Number (SRN) details for a specific holder; and
- the Registry to respond to the Participant's request for Securityholder Reference Number details.

#### **Procedure**

- 3.11.2.1 The Participant submits a Securityholder Reference Number (SRN) enquiry request to CHESS.
- 3.11.2.2 If the request is successfully validated by CHESS, the request is transmitted to the appropriate Registry.
- 3.11.2.3 Upon successful investigation, the Registry transmits the requested details to CHESS. CHESS transmits a message to the Registry confirming the response has been processed and transmits the details to the Participant.
- 3.11.2.4 Unsuccessful investigations result in a rejection being transmitted by the Registry to CHESS. CHESS transmits a message to the Registry confirming the rejection and transmits details of the rejection to the Participant.

## 21.3 ISSUER SPONSORED HOLDING BALANCE ENQUIRY

The purpose of Holding Balance Enquiry is to enable:

- A Participant to request a Registry to provide an Issuer Sponsored holding balance for a specific holder; and
- the Registry to respond to the Participant's request for an Issuer Sponsored holding balance.

#### **Procedure**

- 3.11.3.1 The Participant submits an Issuer Sponsored holding balance enquiry request to CHESS.
- 3.11.3.2 If the request is successfully validated by CHESS, then the request is transmitted to the appropriate Registry.
- 3.11.3.3 Upon successful investigation, the Registry transmits the requested details to CHESS. CHESS transmits a message to the Registry confirming the response has been processed and transmits the details to the Participant.
- 3.11.3.4 Unsuccessful investigations result in a rejection being transmitted by the Registry to CHESS. CHESS transmits a message to the Registry confirming the rejection and transmits details of the rejection to the Participant.
