Commonwealth Bank of Australia ("CommBank") - Reinvestment of CommBank PERLS III into CommBank PERLS VIII Capital **Notes**

PERLS III Holders entering the register after 7.00pm (Sydney time) on 22 February 2016 are not entitled to participate in the Reinvestment Offer.

Participants may submit elections through CHESS for Eligible PERLS III CHESS Holders to participate in the Reinvestment Offer.
