## Minerals 260 Limited (ASX: MI6) – Anticipated Reinstatement to Quotation

### Description

It is anticipated that the securities of Minerals 260 Limited ('MI6') will be reinstated to quotation at 10:04:30 (+/- 15 seconds) AEST on Thursday, 10 April 2025, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

MI6 raised A\$220,000,000 pursuant to the offer under its prospectus dated 28 February 2025 by the issue of 1,833,333,333 shares at an issue price of A\$0.12 per share.
