InVert Graphite Limited – (ASX: IVG) – Anticipated Reinstatement to Quotation

Description

It is anticipated that the securities of InVert Graphite Limited ('IVG') will be reinstated to quotation at 10:04:30am (+/- 15 seconds) AEST on Tuesday, 10 June 2025, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

IVG raised \$3,500,000 pursuant to the offer under its prospectus dated 13 March 2025 and as varied by the supplementary prospectus dated 7 April 2025, by the issue of 116,666,667 shares at an issue price of \$0.03 per share.
